Notes:

Letter not posted until 15 January 1849. Although the retaliatory rate had been rescinded a few days earlier, the New Orleans postmaster continued to charge the 24¢ retaliatory fee on this letter, perhaps the last time he charged it. As a result the letter was overcharged 24¢ since the inland rate to New York was 10¢. Letter carried on last of three Cunard voyages to the U.K. during the restored rate period. Postage due in Crest of 25 decimes included 10 decimes pay back to G.B. and 15 decimes French internal fee for letter up to 10 grams travelling 700 km from Boulogne to Crest.

Letter carried "out of the mails" to Charleston, probably on the steamship Isabel from Havana. Forwarding agent in Charleston paid 2x24¢=48¢ for a double rate letter under the new U.S.-G.B. postal convention. Charleston learned of the new convention on 9 January 1849, but did not know it was not yet in effect. Prepayment was a very large overpayment of the 2x10¢=20¢ restored rate fee to get letter to Boston. Letter carried on 2nd of three eastward voyage of the Cunard Line during the six week restored rate period. Postage due for this 15 gram letter included 20 decimes to G.B. and 13 decimes French internal fee for a 15 gram letter going 215 km. from

Boulogne to Paris.


