Aachen marked boxed AMERICA per ENGLAND handstamp and letter weight of 1¼ loth. Aachen converted 3s6d to 35 sgr. and added 6½ sgr. Prussian transit fee for total of 41½ sgr. or 417 npf. Saxony added 65 npf. for total of 482 npf. postage due. Scarce retaliatory rate cover to Germany.

New York marked the letter for triple the retaliatory rate, 3 x 24¢ = 72¢ since it was addressed to the arrival port. One other letter from the same correspondence and mailed at the Tooley Street receiving house is known with a 3 shillings payment.
