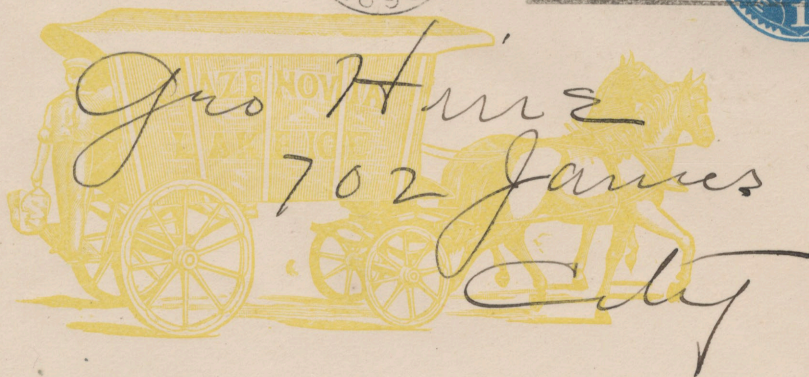
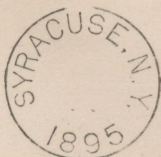


VIEW OF RUTLEDGE MINE.

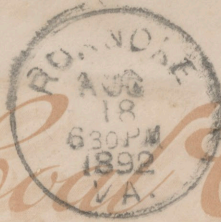

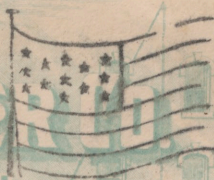
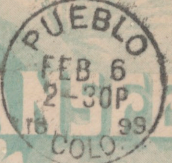
