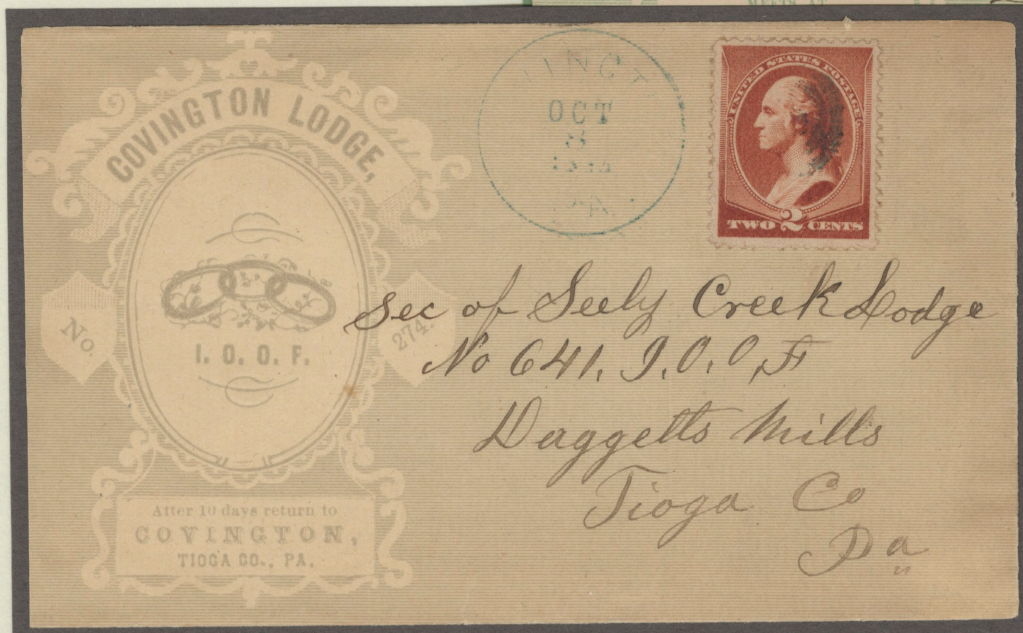

SILVER LAKE Chautauqua Assembly.

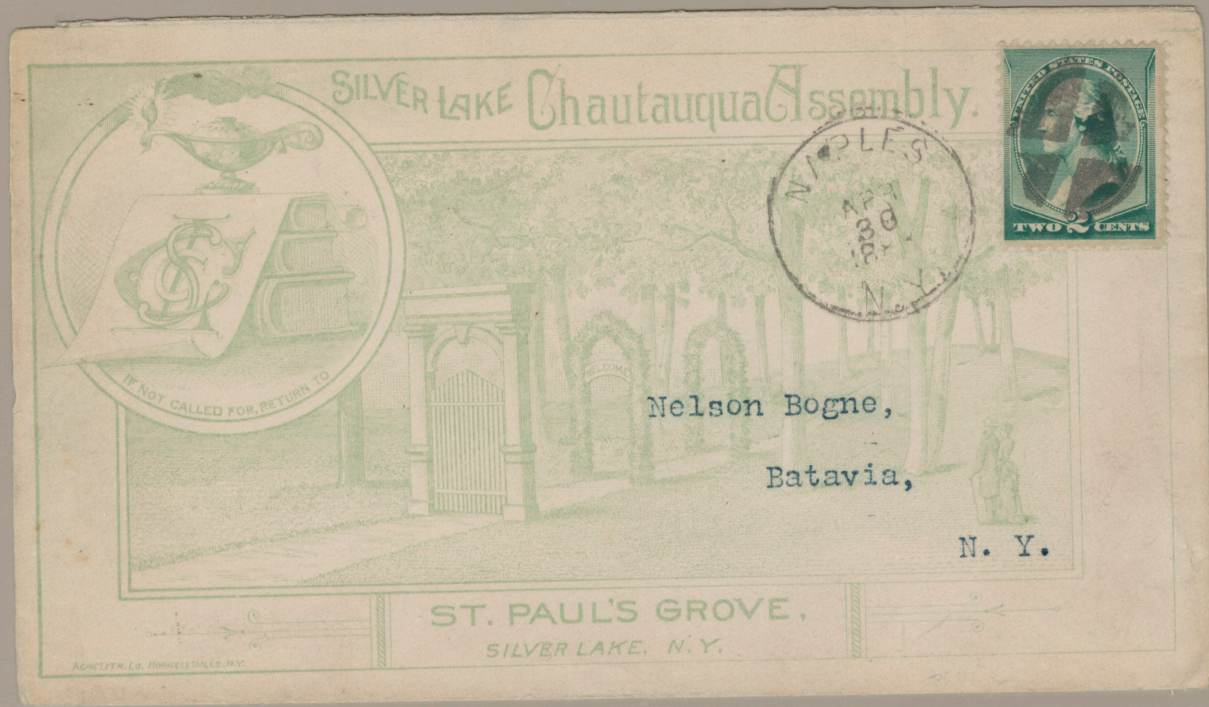

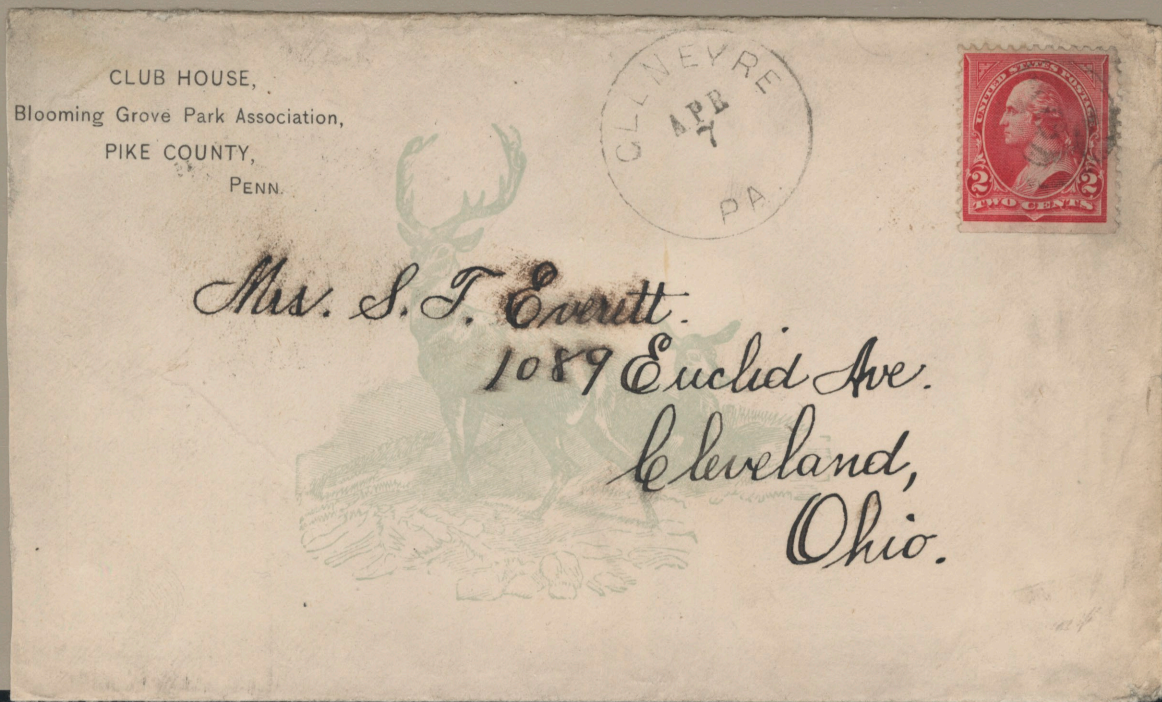

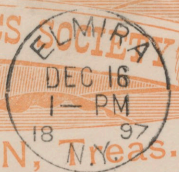
