"Tabacalera" is the trade name of "Compania General De Tabacos De Filipinas", the largest manufacturer of cigars and cigarettes in the Philippines.

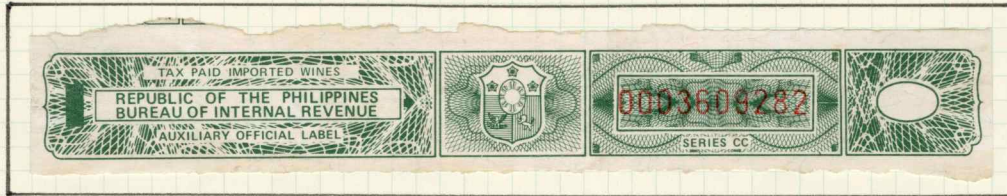

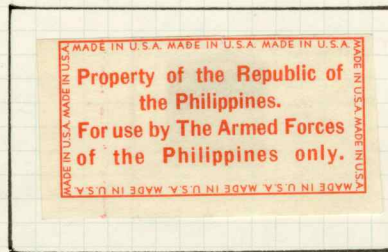

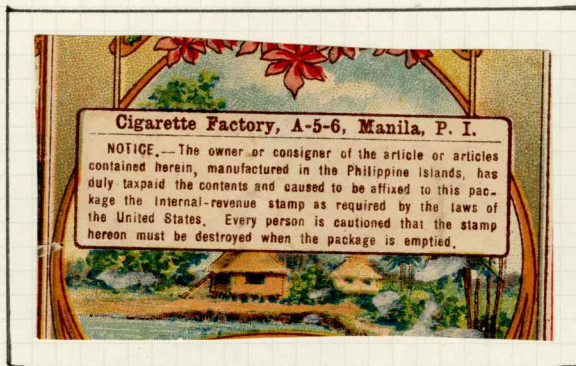
Compounded Tax Paid Liquor

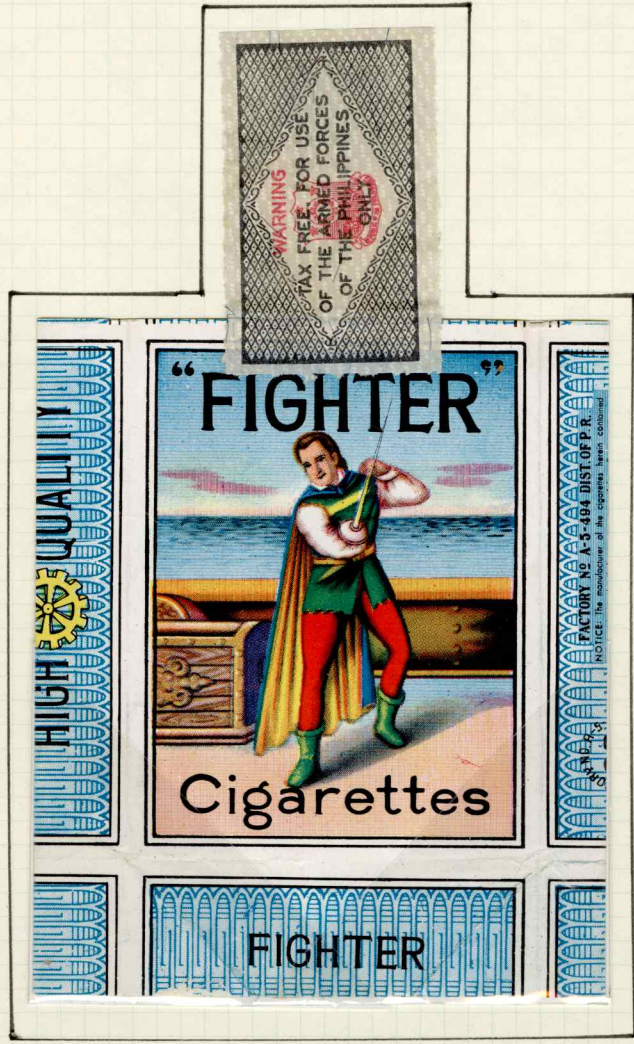

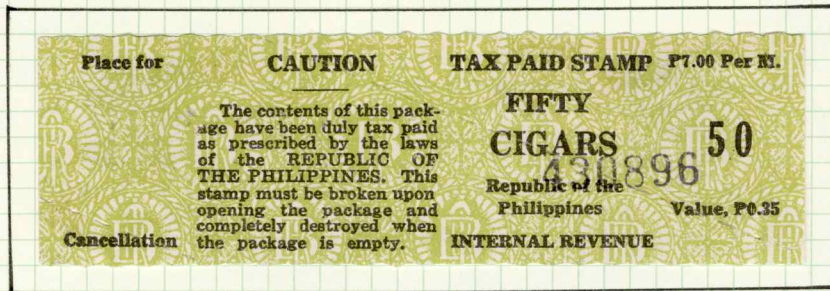
