1209 1934, May 25 -- Naval Survey Flight over Pacific Ocean. The U.S. Navy undertook a naval reconnaissance flight over the Pacific Ocean. A naval plane piloted by Lt. J.P. Whitney was catapulted from the U.S.S. "San Francisco" at Hilo Harbor, Hawaii, reconnoitered around the Pacific for a considerable distance and then returned to the naval base at Honolulu. Cover has cachet "Catapulted off U.S.S. San Francisco, Hilo Harbor, Lt. J.P. Whitney, Pilot." Cancelled U.S.S. "San Francisco", May 25, 1934, 9 A.M. U.S.N. Air Mail to Honolulu.
