in the Court of Common Pleas, before the Justices of the said Court, at *Shelburn Court house*

claim *Debt*, and also the Sum of *seven Dollars*, for

Shelley's right *Penal*, for

Costs and Charges by *him* expended in and about prosecuting *his* Suit in that behalf, whereof the said

William Hill is convicted, as appears on Record.

And that you have the Money before the said Justices, at the Court of Common Pleas, to be holden at *Shelburn Court house* on the *second* *Monday* *after* the *next*, to *render to the said* *fourth* *Monday* *in* *March* *next* & *under* & *the* *rule* *of* *the* *said* *Court* *for* *the* *discharge* *in* *Damages*, *Costs* *and* *Charges* *aforsaid*. And have you there this Writ, before the Clerk of the said Court, *four* *days* *next* before the fitting of the said Court.

Sprunke* *Senior* *Justice* *of* *the* *said* *State*, *at* *Shelburn Court house* *the* *fifth* *Day* *of* *November* *in* *the* *Year* *of* *our* *Lord* *One* *thousand* *four* *hundred* *and* *ninety* *four* *and* *in* *the* *Seventh* *Year* *of* *the* *Sovereignty* *and* *Independence* *of* *the* *United* *States* *of* *America*.
