1928 LUCKNOW & LAHORE DEAD LETTER OFFICES, boxed h/s on postal card dated TREVASKISTIANDI APR20'1928 to NAGINA, redirected a number of times and finally locating the addressee at BINOR, REFUSED and returned to sender via the LAHORE-DLO + LUCKNOW-DLO + SONERAT-DELI, a bit of travel wear from the 21 day trip, great markings and F (\$40+ US) \$60+



Up to now (1966) this is the only example known to me. It is an interesting contrast to the item above, which did not involve the Dead Letter Office. And if, as it says, it was used only when an item of mail had to be RETURNED to a D.L.O., it to have a 1st "go" at, no wonder I've not come across this Miscellaneous Postmark before.
