The press of progress rather than the agitation of homesteaders brought about the formation of Oklahoma Territory. Initially the territory was composed only of the unoccupied surplus lands of the Indian Nation. Just prior to Statehood however it included all of the area except that occupied by the five civilized tribes.

This with the Indian Territory became the State of Oklahoma. November 16, 1907.

PEORIA RESERVATION

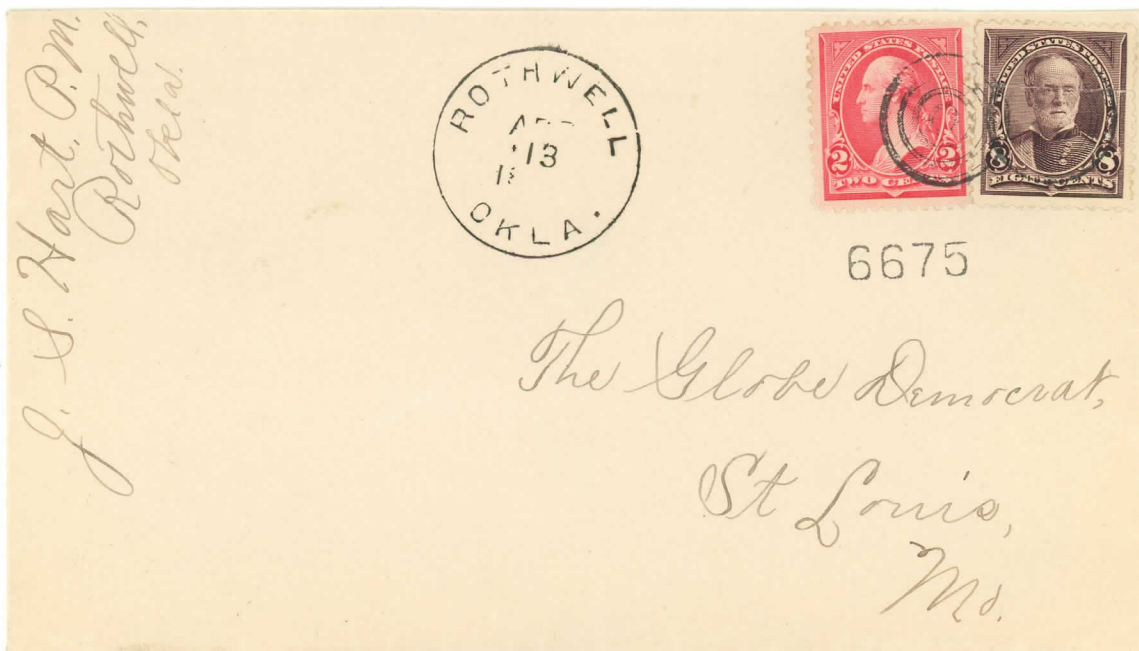

NEUTRAL STRIP

Located west of the Cherokee Outlet, north of Texas, south of Kansas, the western boundry was not defined. This, with the Cherokee Outlet became the roaming home of the "ne'er-do-well" and "badman" both White and Indian, many areas were without law. The section finally was a part of the Cimarron Land Rush.

with the Indian Tribes, in particular those who made up

- Choctaws - Chickasaws - Creeks - Seminoles. Later many
smaller tribes were removed to the territory.
