



BLACK JACK USED AS A REVENUE STAMP


DESPITE A SEPARATE SET OF ADHESIVE STAMPS

THE ACT OF 1864 SEPARATED RECEIPTS FROM CHECKS, MEMOS, DEEDS AND OTHER TAXABLE ITEMS AND FIXED THE TAX FEE ATTWO CENTS ON EACH RECEIPT FOR OVER TWENTY DOLLARS, THUS THE REASON THE TWO CENT BLACK JACK WAS USED ON OCCASIONS.



THE USE OFOUR POSTAGE STAMPS AS REVENIUES WAS NOT INTENDED HOR WAS IT AUTHORIZED BY LAW. THERE FORE IF DETECTED THE POSTAGE STAMPWRS FITHER COVERED BY AREVENUE OR A REVENUE WAS AFFIXED & THE POSTAGE STAMP IGNORED.
