The letter below is a notice from the U. S. District Court located in New Orleans to a local creditor that a bankruptcy had been petitioned. It is dated September 21, 1868 and shows a New Orleans postmark of the same date. It also shows a November 5, (1868) postmark and an "UNCLAIMED" marking. Franking was with the 2¢ "Blackjack" of the 1863 issue.
