

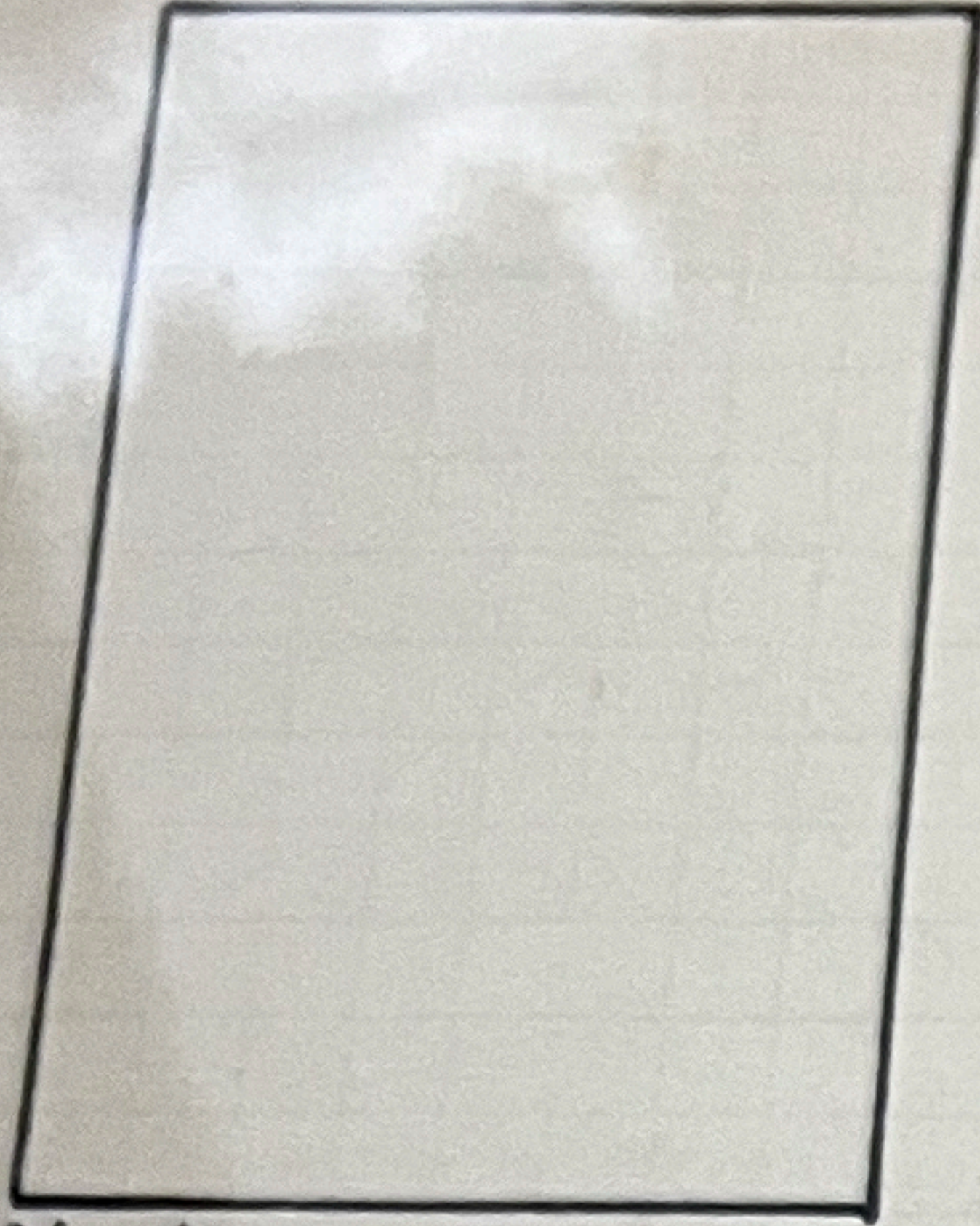

50,000 and 26th Mar 1900 - 70,000.



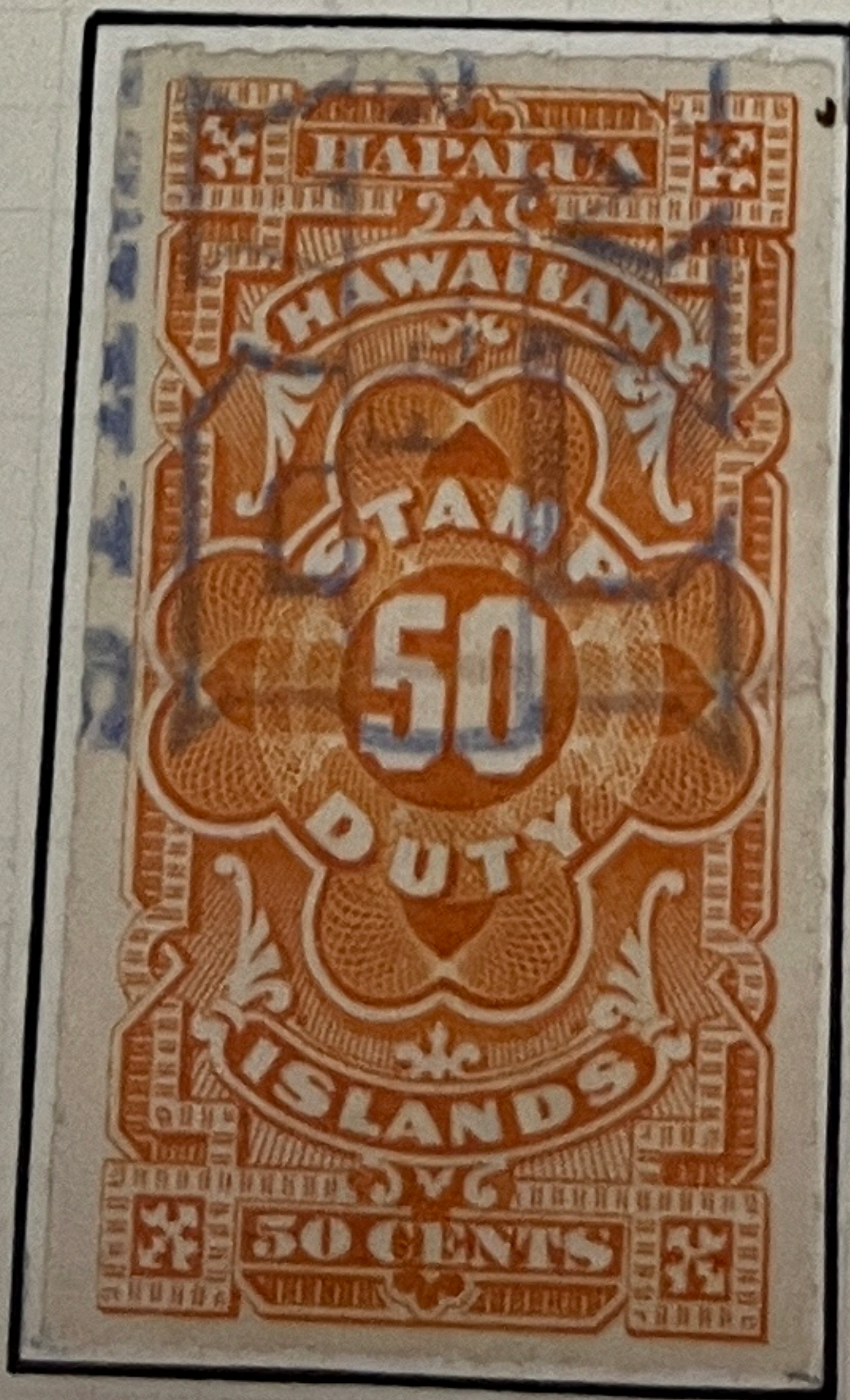
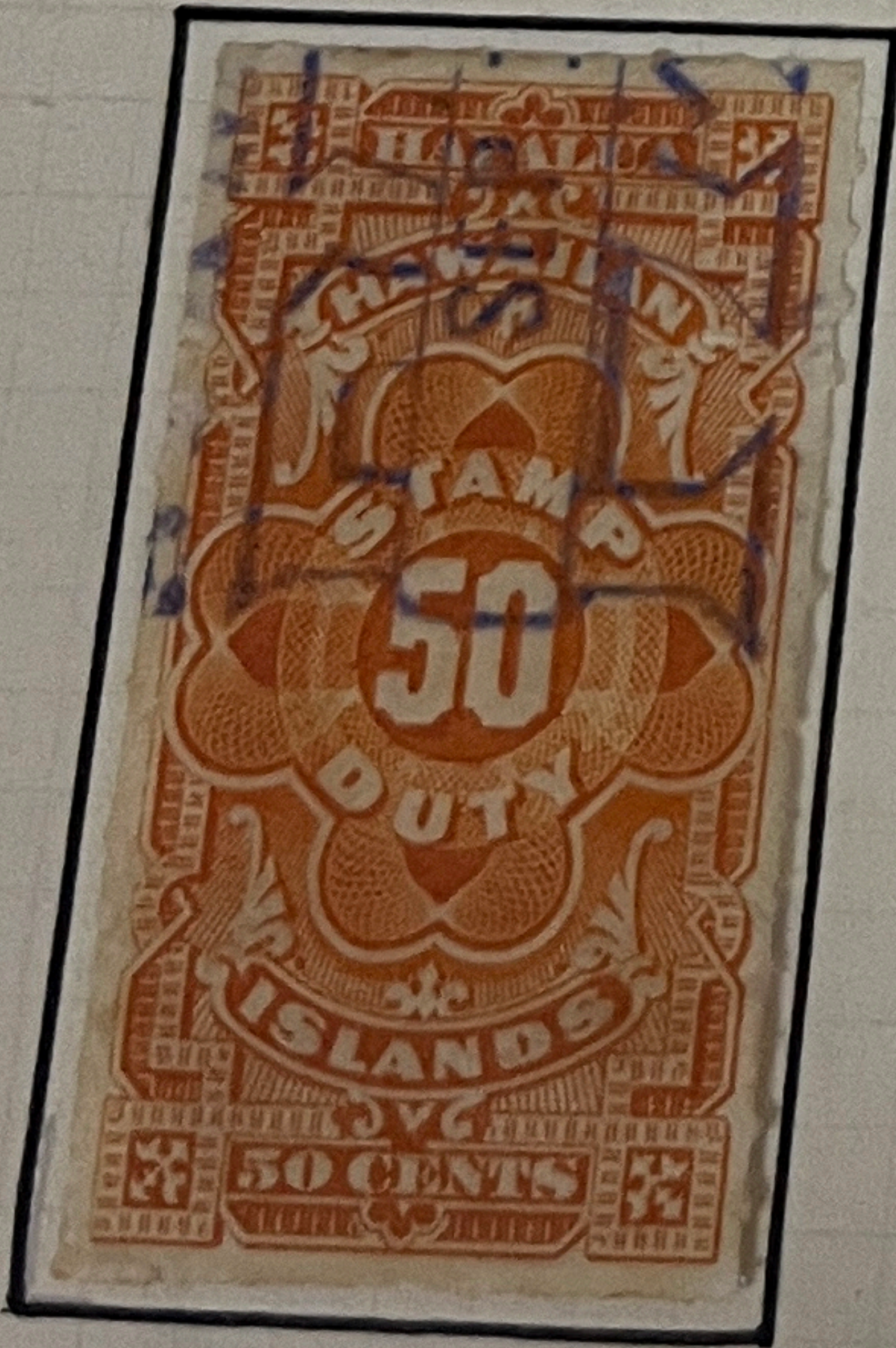
