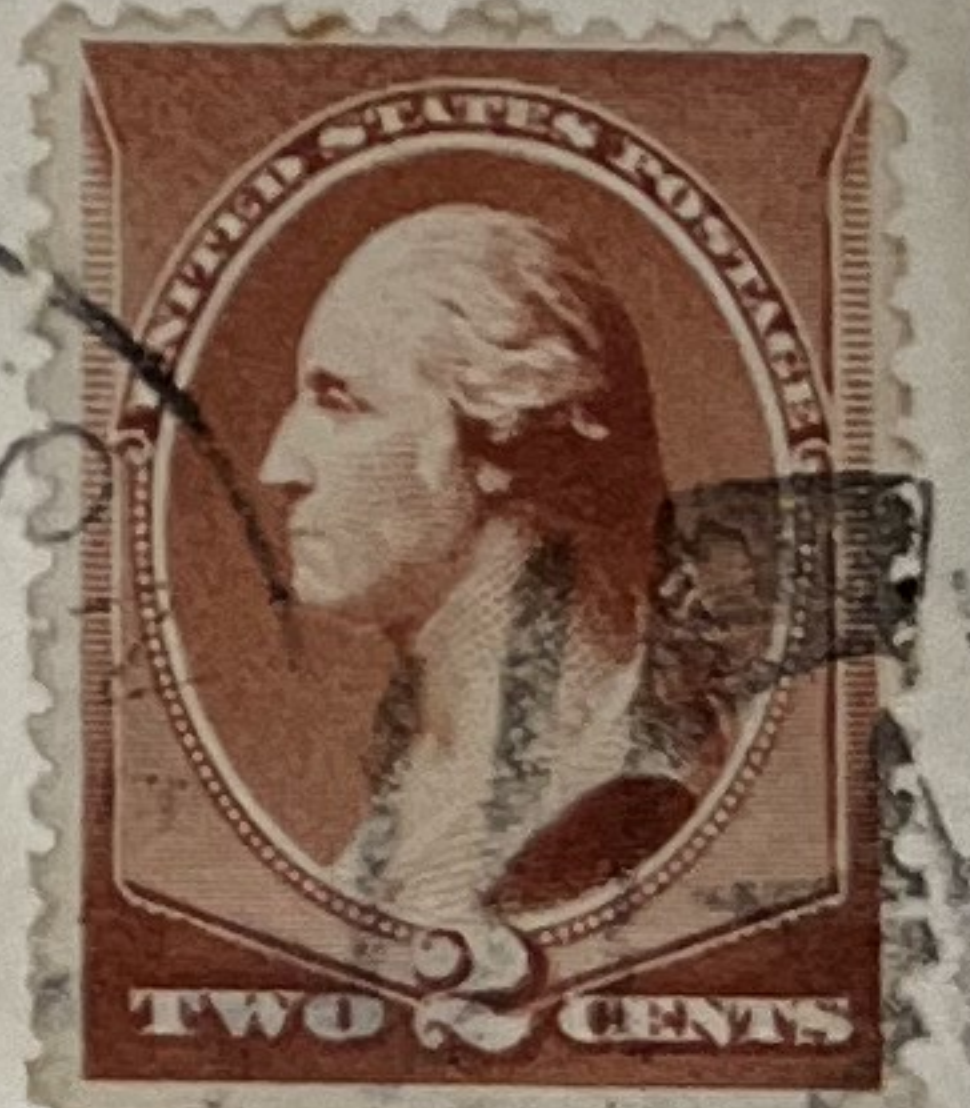

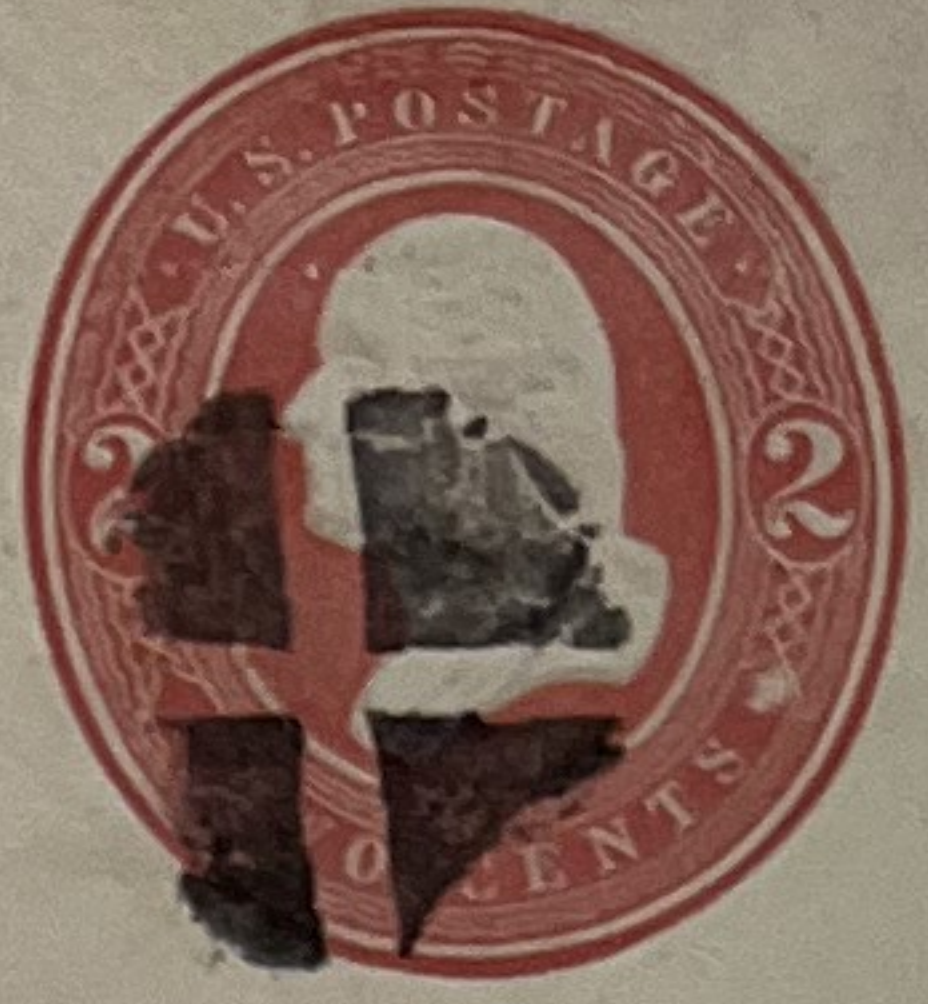

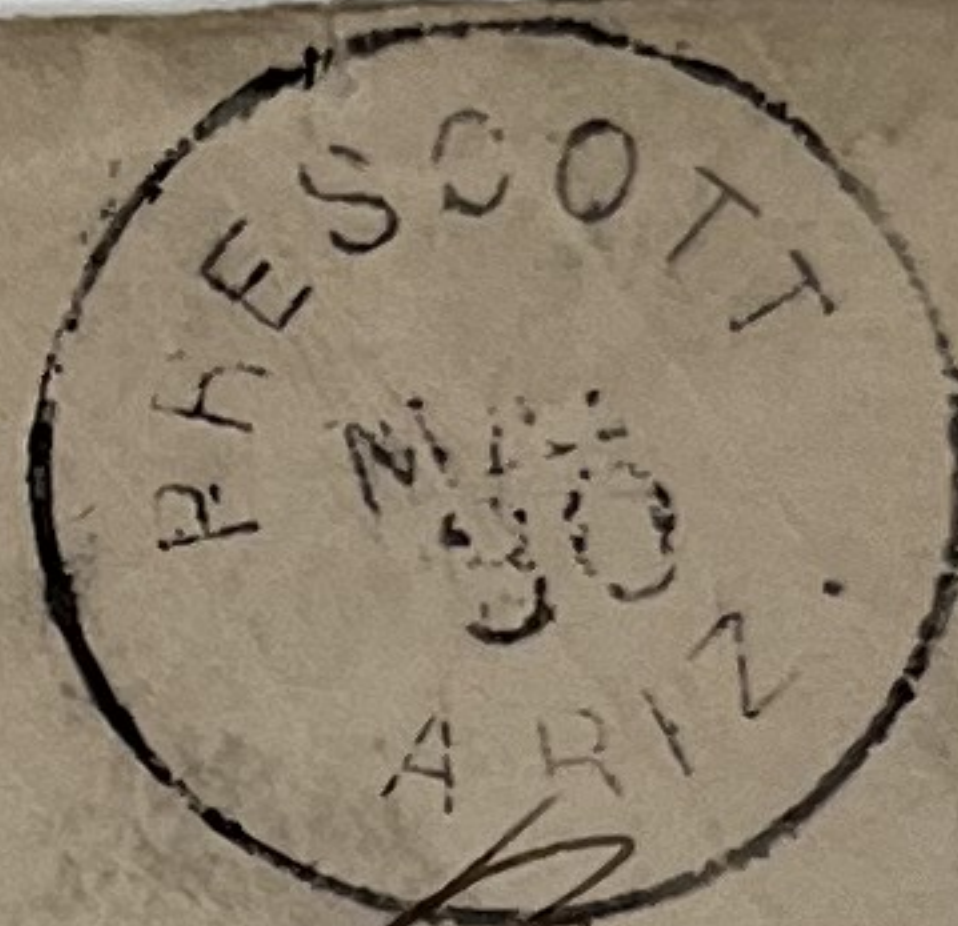
My Dear Little Boy
